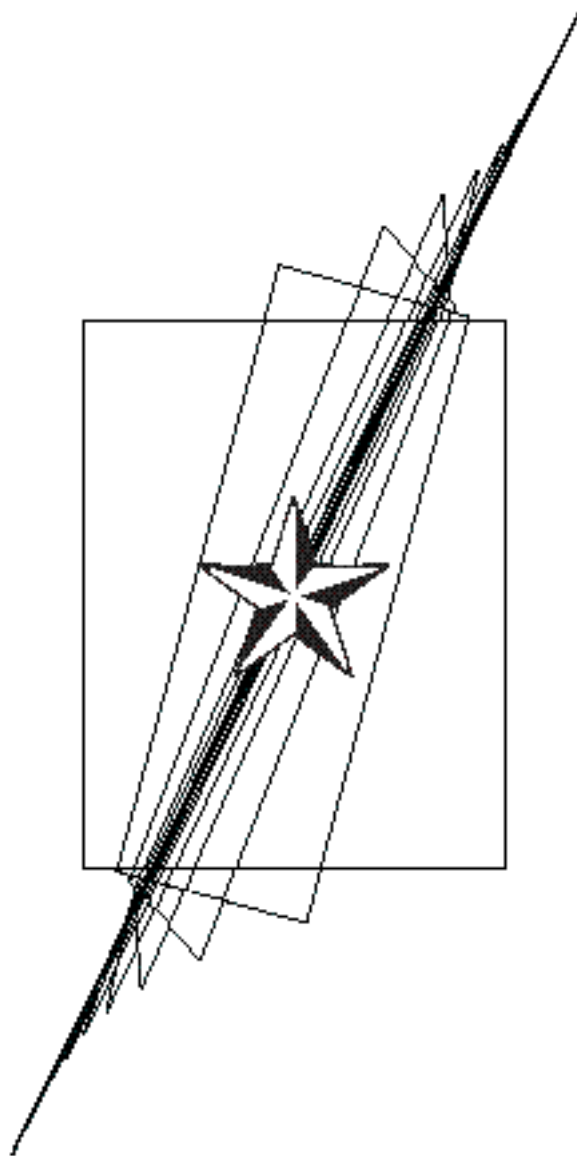

## IP Academy

The IP Academy of the Intellectual Property Office of the Philippines is the national center for IP learning and research. The IP Academy, a unit under the Office of the Director General of IPOPHL, is tasked to promote knowledge and awareness on intellectual property for national development through education, training, and research. Under its Education pillar, the IP Academy aims to strengthen linkages with academic institutions to mainstream the integration of IP in the curriculum of both lower and higher education systems, along with the creation of specialized post-graduate courses for IP. Under its Training pillar, the IP Academy aims to implement an extensive spread of awareness through short and long courses specifically tailored to different professions and fields, such as the MCLE program for lawyers, Summer School and Beyond IP Mastercourse for various professionals, IP Boost Camp for students, and targeted IP Forward>> IP Masterclass programs for different work and social sectors. Under its Research pillar, the IP Academy aims to accelerate the transfer of technology and initiation of innovation through creation of research studies under the IPOPHL - De La Salle University Research Conference, the IPOPHL internal research capacity-building program IP REACH, and the Asia Pacific Journal on IP Management and Innovation

## The DLSU Innovation and Technology Office

The De La Salle University (DLSU) Innovation and Technology Office (DITO) is the university's provider of patent services and knowledge and technology transfer support services. The DITO was established in 2011 to perform the functions of an Innovation and Technology Support Office (ITSO) of the Intellectual Property Office of the Philippines. DITO's mission is to support the transformation of research outputs into innovations that benefit society. To achieve this mission, the DITO supports university knowledge and technology transfer – in coordination with the DLSU Intellectual Property Office (DIPO) – strengthens relationships between the university and third parties, capacitates its stakeholders in the commercialization of intellectual property (IP), provides quality patent services, and contributes to knowledge in the intellectual property (IP), innovation, and knowledge & technology transfer disciplines. As of June 2022, the DITO has filed 33 patents and 8 utility models for DLSU, of which 12 patents have been granted and 7 utility models registered. It has also filed 2 utility models for an external client, both of which have been registered. The DITO has filed 2 international patent applications for DLSU via the Patent Cooperation Treaty, both of which have been filed as National Phase applications in 4 countries each. Through DITO's efforts, DLSU was recognized by the IPOPHL as a top patent grantee/registrant for the period 2017-2021. As of June 2022, the DITO is supporting 3 university spinoffs, one of which has received a license from the university to commercialize DLSU-owned IP. The Office has also negotiated numerous partnership agreements with industry for the purposes of collaborating on innovation-related initiatives. The DITO organizes the DLSU Innovation and Technology (DITECH) Fair, an annual event for showcasing Lasallian innovation, discussing innovation trends, and bringing together participants of the innovation ecosystem. The DITO seeks to contribute to the building and growth of the country's innovation ecosystem, where problems are solved through the collaborative efforts of government, industry, and academia, where IP is respected, and where entrepreneurship is valued.

## The DLSU Intellectual Property Office

The DLSU Intellectual Property Office (DIPO) is a unit under the Office of the Vice President for Research and Innovation (OVPRI) of De La Salle University (DLSU) and is the IP Management and Technology Transfer Office of DLSU. In 2008, DLSU was among the first private universities in the Philippines to establish an Intellectual Property (IP) Office, and to draft and implement a set of comprehensive policies on IP. DLSU through the DIPO has also set the record for being the first university to set up the Intellectual Property Advocates (IPA), a student organization that promotes within its ranks greater awareness, advocacies, initiatives and respect for IP which was complimented by former Director General Ricardo R. Blancaflor of the Intellectual Property Office of the Philippines (IPOP HL). The DIPO was envisioned, among others, to educate the academic community first, then society on the important role of IP protection in securing inventions, facilitating technology transfer, and encouraging inventors to disclose their work. Its mission is to promote awareness, manage assets, and implement policies pertaining to intellectual property, creating an environment where innovation and creativity can flourish. This mission can be strategically achieved by pursuing activities that cultivate awareness and nurture respect for IP, creating IP Champions along the way. Through the years, the office has achieved certain milestones. Last year, the DIPO was able to offer the Online Strategic Management of Intellectual Property (SMIP) Basic and Advanced Certificate Courses in partnership with the USAID-STRIDE-funded DLSU Skills in Technical and Advanced Research Training (START) Hub. It has also established partnerships with various industry players, local government agencies and international organizations in promoting IP and innovation. Last 2019, the DLSU through the DIPO signed a Memorandum of Understanding (MOU) with IPOP HL to (1) create and manage the Asia Pacific Journal of Intellectual Property Management and Innovation (APJIPMI) and (2) design a Master's Program on Intellectual Property Management and Innovation (MIPMI). Just this year, the World Intellectual Property Organization joined the DIPO and the IPOP HL IP Academy via an MOU in preparing for the MIPMI which is set to be offered by September 2023. Together with creating IP awareness activities, is the continuous service to the academic community in protecting the IPs of its students, researchers, and employees. The DIPO continuously provides assistance in IP disclosures, university trademark management and copyright deposits. The DIPO's commitment is not just bound within the walls of the University. It will continuously pursue efforts to make sure that Intellectual Property and Technology Transfer positively impacts national development, progress, and the common good.
