A PROPOSED METHOD OF CORRECTING THE CONSTRUCTION ENTRIES IN THE 2006 PHILIPPINE INPUT-OUTPUT TABLE

Abstract

The construction of national input-output (IO) tables follows internationally acceptable standards such as the United Nations Systems of National Accounts (UN SNA) and European System of Accounts (ESA). These standards are used to ensure tractability and coherence between country tables. The 2006 Philippine IO table published by the Philippine Statistics Authority (PSA) assumes that the construction sector does not provide any input to the production of output for any economic sector. With the booming infrastructure development in the Philippines, this assumption that intermediate demand for construction output has a value of zero is unreasonable. This study proposes a corrective approach to determine the entries for the construction sector by utilizing the sectoral shares of intermediate demand from the 2000 Philippine IO table. This yields a more realistic inter-industry transactions matrix that will provide better insights for economic planning and impact analysis.

CORRECTION OF THE CONSTRUCTION ENTRIES IN THE 2006 PHILIPPINE INPUT-OUTPUT TABLE

Introduction

Input-output (IO) analysis was developed by W. Leontief (1936) as a systematic tool for analysing the interdependencies between economic sectors for which he won the Nobel Prize. The rows of the IO table show the monetary value of each sector and each agent's consumption for a specific sector, which sums up to the total output of the specific sector. The columns of the IO table present the monetary value of a sector's demand for each of the other sectors' output, which is used as an input for its production, or the total input. It should be noted that total input and total output are equal at all times.

National statistics offices are usually tasked to publish official IO tables for each country. These serve as a basis for economic planning as well as regional and global analysis with the emergence of multi-regional tables. Hence, there is a need to ensure that national IO tables satisfy internationally acceptable standards such as the United Nations Systems of National Accounts (UN SNA) and European System of Accounts (ESA).

Each country publishes its IO tables at varying frequencies. For example, developed countries such as the United States, Japan, and European Union countries publish IO tables on an

annual basis (United States Bureau of Economic Analysis, n.d.; EUROSTAT, n.d.). Due to the costly nature of constructing such database, developing countries publish IO tables less frequently. In the case of Singapore, once every three years (Department of Statistics Singapore, n.d.), in Malaysia, once every five years (Department of Statistics Malaysia, n.d.) and in the Philippines, it is published on an irregular basis (Philippine Statistics Authority, 2016).

IO analysis has also been used to show the economic contributions of a sector to the economic growth and tax collections (Katz & Koutroumpis, 2012). Technical coefficients can also be used to observe structural changes over time. Soliven, Villaquer, and Zozobrado (2004) analysed the transformation of the Philippine IO tables across 25-year period. Aside from interindustry transaction analysis, IO analysis is also useful for assessing policy impacts on employment. Magtibay-Ramos, Estrada, and Felipe (2007) used IO analysis to estimate the employment generation and output expansion resulting from influx of business process outsourcing sector activities. Beyond the traditional IO analyses, IO tables also serve as a fundamental input to the construction of a social accounting matrix (SAM). The SAM is a comprehensive dataset that includes income and expenditure of various economic agents (Round, 2003). Integrating the SAM with a computable general equilibrium (CGE) model will yield insights for policy impact evaluation such as imposing quantitative restrictions on rice (Cororaton, 2004), using agricultural crops for biofuel feedstock (Rodriguez & Cabanilla, 2008), and increasing infrastructure spending (Savard, 2010) among others. Further extensions on the IO model to account for disruptions to the economy resulting from natural hazards (Yu, Tan, Aviso, Promentilla, & Santos, 2014; Aviso et al., 2015a; Yu, Aviso, Promentilla, Santos, & Tan, 2016) and mandatory biodiesel blending (Aviso et al., 2015b) have also been implemented.

The volume of economic studies hinged on IO data is growing in number. While the latest Philippine IO table published by PSA is for the year 2006, previous studies remain to use the 2000 Philippine IO table. According to PSA (2014), the 2006 Philippine IO table adapts the 2008 SNA standards and takes into account the emergence of new industries, which result in new sector classifications. It should be noted that for all sectors, it has been assumed that the Construction sector does not contribute to the production of all other sectors including itself given that the entire row which sums up to intermediate demand has a value of zero. Despite this, the column entries of the Construction industry have a total of PhP 4,206.9 Million, while the row entries yield the same total amount, satisfying the basic assumption that the row sum should equal the column sum for each sector. Furthermore, in the 2006 Philippine IO database, gross fixed capital formation (GFCF) was disaggregated into four categories such as Construction, Durable Equipment, Breeding Stock & Orchard Development, and Intellectual Property Products (PSA, 2013). Since total output of each sector is the sum of intermediate demand and final demand, and intermediate demand for the Construction sector was assumed to be zero, the row sum and column sum remains equal as the GFCF for construction of the Construction sector amounts to PhP 545,199 million. Revisiting the definition of GFCF in the 2008 SNA as the "total value of a producer's acquisitions, less disposals, of fixed assets during the accounting period plus certain specified expenditure on services that adds to the value of non-produced assets" (United Nations, European Commission, International Monetary Fund, Organisation for Economic Co-operation and Development, & World Bank, 2009, p. 623). In Paragraph 10.54, the definition of GFCF excludes assets that take some time to produce such as construction projects and some cultivated biological resources, only if these assets are on their own account will they count as GFCF (United Nations et al., 2009). While some firms have the capacity to engage in construction activities on their own, most firms will employ other firms to build such assets, which under the 2008 SNA definition will count as intermediate consumption from the Construction sector.

This paper proposes a simple procedure to reconcile the 2006 Philippine IO table entries and account for the contributions of the Construction sector to the production process of other sectors in the Philippine economy. The succeeding sections are organized as follows: Part 2 discusses the procedure, Part 3 shows the correction of the Construction sector and the valueadded, and Part 4 presents the conclusion and recommendations.

Procedure

The paper proposes a simple way of adjusting the entries for the Construction row. The 2000 Philippine IO table is used as a reference value for the inter-industry dependence of the other sectors to the Construction sector. The total value of the intermediate demand for the Construction sector in 2000 is PhP 19,873.82 million. The share of each sector is computed using Equation (1):

$$SecShare_i = \frac{ID_j}{TID}$$

where *SecShare_i* is the share of the intermediate demand of sector *i* from the total output produced by the Construction sector; ID_j is the monetary value of intermediate demand of sector *j* for the output of the Construction sector; and finally, *TID* is the total intermediate demand of the Construction sector. Note that the ID_j and TID are in monetary values while the *SecShare_i* is in percentage.

The computed share of the intermediate demand for each sector from the 2000 Philippine IO table is then used in computing for the row entries in the 2006 Philippine IO table. The value of the intermediate demand, ID_i , is determined using Equation (2).

$$ID_i = TID_{2006} \cdot SecShare_i \tag{2}$$

It is assumed that the GFCF for the Construction sector is the total intermediate demand for the Construction sector in 2006 TID_{2006} , which is approximately PhP 545,199 million.




Figure 1: Summary of the procedure.

However, it was also observed that some of the sectors in the 2000 Philippine IO table are not present in the 2006 IO model and vice-versa. Majority of these sectors were found specifically in the manufacturing/industrial sectors (i.e. manufacturing of motors, wood furniture, etc.). This may be explained by the emergence of some major sectors and the decrease in economic activities that contribute to the economy between the years 2000-2006. In the procedure done, some sectors were either aggregated or disaggregated in the 2006 Philippine IO table to be able to match the 2000 Philippine IO table. However, some disaggregated sectors in 2006 Philippine IO table were assumed to have an equal share from the 2000 Philippine IO table for simplicity purposes. Figure 1 shows the summary of the procedure.

Adjusting the Construction Industry and the Value-Added

In the 2006 Philippine IO table, it was assumed that the total intermediate demand of the Construction sector is PhP 545 billion. Each sector's intermediate demand was computed from the 2000 Philippine IO table to adjust the missing entries in the 2006. The sectoral share is then multiplied to PhP 545 billion to get the corresponding monetary value for each sector. Table 1 presents the sectoral share of the top five highest intermediate demands for Construction output. Annex 1 shows the sectoral share of all sectors and the corresponding aggregation or disaggregation of some sectors in the 2006 Philippine IO table.

Top Five Sectors with the Highest Intermediate Demand for Construction Output in Million PhP

It was found that the Public Administration and Defense has the highest intermediate demand for construction output, which has a value of approximately PhP 251.7 billion. The second highest intermediate demand for construction output is the Construction industry itself, which has a value of approximately PhP 47.6 billion. The third highest intermediate demand for construction output is the Ownership of Dwellings sector, or those who are in the construction or home-improvement of houses, which has a value of approximately PhP 46.3 billion. The fourth highest intermediate demand for construction output is the Banking Institutions, which has a value of approximately PhP 28.2 billion. Lastly, the fifth highest intermediate demand for construction output is the Public Education Services, which has a value of approximately PhP 27.4 billion.

After adjusting the row entries of the Construction sector, the next step is to revisit the calculation for value-added in the 2006 Philippine IO table. Value-added is composed of the following: (1) Compensation of Employees, (2) Consumption of Fixed Capital, (3) Indirect taxes less subsidies, (4) Operating Surplus, and (5) Total Primary inputs. Table 2 shows the adjusted

values of the top five sectors with the highest intermediate demand and their corresponding revised value-added components. Annex 2 shows the revised values of the value-added for all sectors in the 2006 IO.

Revised Value-Added Computation of the Sectors with the Top Five Highest Intermediate Demand in Million PhP

In the revised 2006 Philippine IO table, the total final demand expenditure, which is also equal to the gross value added, has an approximate value of PhP 5.73 trillion. This was found to be lower than the original uncorrected 2006 Philippine IO table, which had a value of PhP 6.27 trillion, a 9.52% discrepancy. This discrepancy is relatively large, considering the error is almost 10% and that the values of the value-added are reported in millions of pesos.

Conclusions and Recommendations

Databases are constructed under certain assumptions. However, when inappropriate assumptions are made, adjustments can be considered to improve the quality of the data. The most recently released 2006 Philippine IO table was constructed under the assumptions of the 2008 SNA, but were unable to account for the exemptions for GFCF. Hence, the need to review and adjust the database.

This study proposed a simple procedure to address the problem, with the assumption that some sectors were either aggregated or disaggregated in the 2006 Philippine IO in comparison with the 2000 Philippine IO table. This assumption preserves the consistency of the sectors that are present in both the 2000 and the 2006 Philippine IO tables.⁴ Equal weights for some of the aggregated/disaggregated sectors were assumed, given the limited information from the given IO tables so such assumption was made to make the adjustment easier. If information on which sectors were either aggregated/disaggregated in the 2006 Philippine IO tables and their exact share of the intermediate demands had been provided, the exact weights could have been correctly computed during the process of correcting the 2006 Philippine IO Table. Unfortunately, the PSA does not provide any technical discussions or notes on sector aggregation; hence, the assumption of equal weights was done by taking the average of the values, which may yield a safer approximation of the shares of intermediate demand for Construction output of the aggregated/disaggregated sectors. Other methods may be adopted in correcting the 2006 Philippine IO table, especially in examining further the sectors that have to be further aggregated

or disaggregated and deriving the exact shares of these aggregated/disaggregated sectors to achieve the actual percentage share of each sector.
